## **NEVADA STATE BARBER'S HEALTH and SANITATION BOARD**



### **Minutes –April 3, 2016 – Regular Business Meeting**

President Nathaniel LaShore called the meeting to order on Sunday, April 3, 2016, the time was 1:15 P.M. at the Masterpiece Barber College, located at 3510 East Bonanza Road, Las Vegas, Nevada.

Board members Ms. Nancy Hathaway, Mr. Nathaniel LaShore, Mr. Ihsan Azzam, Ms. Antinette Maestas, and Ms. JoAnna Wesley-Winn.

The agenda was reviewed and approved as posted.

Ms. Hathaway made a motion to dispense of the reading of the minutes for the January 31, 2016, since everyone had copies and they had been read. The motion included to accept the minutes as submitted. Ms. JoAnna Wesley-Winn seconded the motion and all was in favor.

Ms. Hathaway made a motion to dispense of the reading of the financial report since everyone has read and approved of the report. Ms. Wesley-Winn seconded the motion and all was in favor.

#### **Officers Report**

1. Ms. Hathaway reported that she has been busy up North. Inspecting new shops and answering questions. Doing business as usual. Lots of interest in barbering. She has had a couple of new shops going in.
2. Mr. LaShore reported that he has been doing business as usual. He has been out inspecting. He feels it is important to make the Board present.

#### **Old Business**

Secretary Maestas states that the Bond has been issued and all is in place.

Update on AB 63 – The Veteran's questioner has been sent out and we are getting response.



There will be no meeting in June but the next exam will be June 5, 2016. The following exams will be August 7, 2016 with a meeting, October 2, 2016 with a meeting and ending the year December 4, 2016 no meeting.

### **New Business**

**Quinton Smith** – Mr. Dedmon came before the Board to be able to test in Nevada. He has a felony on his record. Mr. Smith was licensed in Minnesota. Those license have expired in 2010. Ms. Hathaway made a motion to allow Mr. Smith to examine in Nevada providing he submit a certified transcript from the State of Minnesota and he attend a 250 hour refresher course. He would test as an apprentice barber. Ms. Wesley seconded the motion and all was in favor.

**Charles Tucker** hearing – Mr. Tucker came before the Board to be able to attend school. He has a felony on his record. He was released on May 6, 2013. He has documentation of everything. Ms. Hathaway made a motion to allow Mr. Tucker to attend barber school. Ms. Wesley-Winn seconded the motion all was in favor.

**Andrew Frazier** hearing – Mr. Frazier came before the Board to be able to attend school. He has a felony on his record and wants to attend Barber School. The felony was in 2011 for burglary and he was released September 9, 2014 with an honorable discharge. Ms. Hathaway made a motion to allow Mr. Frazier to attend Barber School, Ms. Wesley-Winn seconded the motion and all was in favor.

**Antonio Jones** hearing – Mr. Jones came before the Board he was issued a citation on January 23, 2016 for having an unlicensed individual in his barber shop, Platinum Cuts. The individual that was there is a braider. She was in a room that was not licensed. On November 16, 2013 this same individual got a citation for the same thing, working as a braider in the same shop. Mr. Jones came to a hearing and the fine was reduced to a warning. Mr. LaShore went in and asked if he could get services and the individual told him she did not do that she braided. Mr. Jones told Mr. LaShore that Mr. Eloy Maestas told him when the shop was inspected that he could use that room for a Cosmetologists. Mr. Maestas was a witness at the hearing and said that he had told Mr. Jones at the time of inspection that he could use that room if it was licensed as a cosmetologists room. He would have to submit a new application and floor plans when he changed the room. Mr. Jones never got the room licensed. Ms. Hathaway asked if the individual's license were posted, Mr. LaShore stated that the individual's braider license were posted. Ms. Hathaway made a motion that the fine stand as is. Ms. Wesley-Winn seconded the motion and all was in favor.

**April Williams** hearing – Ms. Williams came before the Board to be able to attend school. She was in Platinum Cuts Barber Shop working as a braider when an inspector came in. She did receive a fine. She is Mr. Jones' sister. Her license were posted in the room. Ms. Hathaway explained that this is the second time she has been caught. There was a violation. Ms. Wesley-Winn made a motion that the fine stand, Ms. Hathaway seconded the motion and all was in favor. Ms. Williams was told that the Board is able to work out a payment plan with her.

**Timothy Avalos** hearing – Mr. Avalos was issued an apprentice license on March 17, 2014, his apprenticeship was up September 17, 2015. He was sent certified letters that were signed for, telling him he must take his registered exam. He failed to pick up an application, and did not take the

examination. Ms. Hathaway made a motion to pull his license, Ms. Wesley-Winn seconded the motion and all was in favor.

**Mr. Joseph Foley, Mr. Trevin Nibblett, and Mr. Ulises Hurtado** took their exams today and there was no need to hear them.

**John Gronvall** – Owner of Aveda Institute Beauty School. They are interested in adding a barbering program. He had some questions for the board. Aveda is coming out with a barbering curriculum. The approved location is one of the questions. Mr. LaShore states that he needed to submit floor plans. Is the location acceptable and does the business have to be separate financial interties or separate physical entities. Ms. Hathaway stated that the board would require separate physical entities. Mr. Gronvall will get the application and get everything turned in.

**Public Comment**

Ms. Wesley-Winn made a motion to adjourn the meeting and Ms. Hathaway seconded. All was in favor.

There being no further business before the Board the meeting was adjourned.

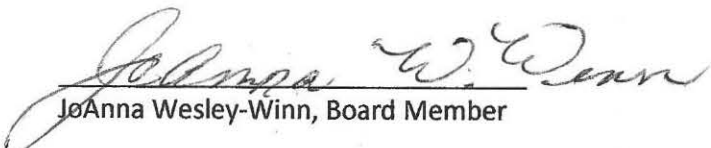
