5. Proposed changes to NAC 643.025 – change wording on endorsement application from individual to owner/manager for affidavits.
6. Proposed changes to NAC 643.450 – remove number of times a year for instructors examination.
7. Proposed repeal of NAC 643.780 – removal outdated amount of fines to current amounts of fines for NRS 643.190.
8. Proposed changes to NAC 643.736 – Adding language to clarify the amount of time a crossover has to take the examination.
